No dog shall be allowed to be off a lead or benching chain unless required by the Judge.

No animal other than an exhibit entered for competition or for exhibition only, shall be allowed within the precincts of a Show, except a registered Guide Dog for the Blind or hearing dog for the deaf or dog requested for educational or instructional purposes or by permission of the Show Committee of the Show -holding Club. **Right of admission reserved.**
