Only Members of the Kennel Union shall be entitled to enter dogs in their registered ownership in any Championship Dog Show licensed by the Kennel Union. This show is held under the Rules & Regulations of the Kennel Union of Southern Africa. All exhibitors are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs. All dogs must be on a lead at all times unless otherwise instructed by the Judge. The Committee reserves the right to appoint alternative Judges, or the appointed Judge is unable to officiate. No animal other than an exhibit entered for competition or exhibition shall be allowed on the grounds with the exception of registered guide dogs. No 'Registration applied for' or 'Transfer applied for' entries will be accepted. There will be no refunds on entry fees for incorrect submission of any information. Entries without payment will not be processed. No late entries will be accepted. Bitches in season are allowed in DI/AG only. Bring hard copies of your payment in case there is a query. Exhibit numbers can be collected from the show office on the day of the show.

Certificates will be issued digitally only. Parking only in permitted areas. Catering available.
